#### **Cajun Classic World Ranking**

- Players compete in the four Grand Slams -- US Open, Wimbledon, French Open, and Australian Open
- Cajun Classic is an ITF Super Series tournament only one in the United States and six in the world
- Cajun Classic is ranked just below Grand Slams
- Like other world-class tournaments, the Cajun Classic must pay stipulated prize money (\$45,000 total)
- Cajun Classic must use USTA certified and ITF badged officials

#### Amateur / Junior Division

- Fifteen Junior amateurs played in the 2023 Cajun Classic
- ITF sanctioned Grade A Junior Tournament
